Tax Deduction Information

You are responsible for determining the value of your donation. Federal law requires that donated items be in good used condition or better to receive a tax deduction. As a rule of thumb, the value of your donation is equal to the price Goodwill is able to sell that item for in our stores.

Per IRS regulation, donors of items valued at \$500 or more should file form 8283 with their federal tax return. If your donation is valued at more than \$5,000, you must submit an appraisal and two completed copies of IRS Form 8283 to Goodwill and the IRS.
