## It is agreed that:

- 1. This dog is purchased for the amount of R \_\_\_\_\_
- 2. The buyer showed interest in buying this dog.
- 3. The breeder sells this dog solely as a companion dog (family dog).
- 4. The buyer undertakes to not use this dog as a breeding bitch or stud dog if health tests are not approved and the breeder had not given written permission.
- 5. This dog is a healthy, happy puppy approved by the veterinarian of the breeder on the date the puppy is handed over to the buyer.
- 6. This dog has been dewormed twice, on 3 weeks and again on 6 weeks. The necessary vaccinations had been done up to date. The vaccination record will be handed over to the buyer with the puppy.
- 7. It is compulsory that the buyer shall have the next vaccinations done at 10 weeks and thereafter as guided by the vet, and send proof of it to the breeder.
- 8. This dog received a microchip positioned on the left shoulder.
- 9. The buyer will receive the KUSA registration documents of this dog either by registered post or when the puppy is fetched.
- 10. That one puppy per agreement is sold to the buyer.
- 11. The buyer should inform the breeder of any health problems this dog may have, in a reasonable time after the condition have become known of. The buyer has the responsibility to inform the breeder in writing for record keeping by the breeder.
- 12. If this dog develops a hereditary disease and must be put down, the breeder agrees with the buyer to indemnify the loss with another puppy in reasonable time. The disease must be identified by a veterinarian and in one year from birth.
- 13. If the buyer, for any reason, wants to rehome this dog, and can not find a suitable home, this dog must be given to the breeder for rehoming. Any costs regarding traveling of this dog will be for the buyer. The buyer do not have any right to ask for a refund of the original purchase price from the breeder.
- 14. The breeder must be informed of any rehoming or change of ownership of this dog.
