

SPIRIT GREAT DANES PUPPY CONTRACT

This contract is solely between named seller and named buyer. A \$50.00 fee is charged for any stop payment, insufficient fund checks, or any closed accounts. Non-refundable deposit of \$500.00 for must be made to hold the puppy of your choice. Payment must be made in full before receiving/shipping puppy.
No refunds will be made of deposits/payments.

1. A licensed veterinarian must check this puppy within 72 hours from the time of pick up.
2. Seller guarantees this puppy to be in good health at the time of pick up or delivery with all vaccinations and de-wormings up-to-date. Dewclaws will also have been removed.
3. Minor health issues that can be cured by medication or minor surgery are not covered by the seller.
4. Seller does not guarantee against hypoglycemia or any other common health issues such as diarrhea, wormy stool, coccidiosis, ear mites, external parasites, and stress due to shipping or new environment.
5. Puppies are susceptible to pneumonia and other infections due to drafts, cold temperature, stress from shipping, etc., and are vulnerable to viral infections including Parvo and Corona Virus. *Seller does not recommend taking your puppy around other puppies or to places that your puppy could catch Parvo or Corona. (such as pet stores, and friends' houses) until all puppy vaccines received. Any and all above mentioned minor and/or major health issues are not covered by seller and puppy needs to be examined by a licensed veterinarian if they occur, and the D.V.M.'s advice should be followed.
6. Seller will not be responsible for accidents after buyer gains physical possession of dog/puppy, regardless of method of shipping and/or pick-up. All responsibilities of the puppy/dog are released at the time you pick up your puppy.
7. Buyer must continue to provide veterinary care, optimum nutrition and shelter for the duration of the dog's life. Buyer will adjust feed to keep puppy in a lean body condition and refrain from giving supplements with the exception of vitamin C and/or Glucosamine in order to prevent growth/joint problems. (NO CALCIUM!) **No strenuous exercise until dog is 18 months old.**
8. No puppy purchased from SPIRIT GREAT DANES is to ever be abused, abandoned or neglected. Owners agree to complete a basic obedience class with their puppy. Owners agree to contact SPIRIT GREAT DANES if, in the future, they are unable to keep their dog for any reason. Dog **MUST BE** either returned to SGD or go to a home approved by SGD. No SGD puppy is ever to be brought to shelter/rescue.
9. All puppies are sold as pets with limited registration and are to be spayed/neutered unless otherwise specified by 1 year of age. Only show quality or breeding quality puppies will be sold with full AKC registration. Dogs intended for breeding must pass health testing prior to breeding.
10. Any puppy sold on full registration must have Spirit Danes in their registered AKC name. Buyer agrees to have both hip and cardiac evaluations prior to breeding any dog and adhere to the ethical breeding standards outlined by the Great Dane Club of America. Buyer also agrees to refrain from breeding bitch on her first heat cycle.

Replacement puppy will be made upon availability and for the same value of the puppy listed above, only if all requirements listed below are met:

1. The dog/puppy is declared to be in a life threatening condition by a practicing licensed veterinarian within 72 hours of buyer obtaining physical possession of named dog/puppy and a written report by D.V.M. is submitted to seller.
2. If the dog/puppy dies within 72 hours, you must have followed your veterinarians advice and have a necropsy performed (at buyers expense), by a state lab and provide seller a copy of the report.
3. Seller is responsible for life-threatening/severely debilitating congenital defects of puppies up to age of 24 months; hip dysplasia, deafness, congenital heart disease, etc. Seller is not responsible for any health/conformation defects later than two (2) years of age, regardless whether buyer contacts seller. If a hereditary problem is found within the first 24 months, the buyer may return the dog/puppy at their expense for another dog/puppy of equal value. Buyer must have provided routine veterinary care and feed dog a quality dog food for this guarantee to be in effect. Proof of care/veterinary records must be furnished upon request. Above condition must be verified by two licensed veterinarians. Buyer is responsible for all associated veterinary costs. Seller is not responsible for skin conditions and growth issues that are diet related.
4. If the buyer does not want a replacement puppy, and chooses to keep the purchased puppy, the Seller may chose to provide a partial refund, provided that the dog has been spayed/neutered and has not produced any offspring.
5. All legal issues to be resolved in Pottawatomie County, Oklahoma. Any violations to contract, such as breeding unregistered dogs, surrendered dogs to shelter, etc. that have to be taken to court are subject to a fine of \$5000.
6. Buyer must provide seller updates on dogs condition with photo at a minimum of once as a puppy and then yearly. These updates are an invaluable tool to help seller evaluate breeding program/health of bloodlines.

There is no oral representation or warranties not contained herein. This contract of sale contains the entire agreement between the two parties. All implied guarantees are hereby excluded. This contract is not valid if not signed by both the buyer and seller.

Buyer acknowledges that any deposit and monies paid for puppy is non-refundable.
