

Unto Life Farm Puppy Contract

TO THE BEST OF THE SELLER'S KNOWLEDGE, THIS PUPPY WAS IN GOOD HEALTH AND FREE FROM ANY SYMPTOMS OF CONTAGIOUS OR INFECTIOUS DISEASE AT THE TIME OF SALE. THE PUPPY WAS VET CHECKED BY SELLER'S VETERINARIAN BEFORE SALE AND A HEALTH CERTIFICATE WAS OBTAINED FROM A LICENSED VETERINARIAN.

UNTO LIFE FARM GUARANTEES THE PUPPY AGAINST LIFE THREATENING CONGENITAL OR HEREDITARY DEFECTS, IF IT DEVELOPS DURING THE FIRST YEAR OF LIFE. THIS DOES NOT INCLUDE COLDS, DIARRHEA, COCCIDIA OR OTHER PARASITES, ALL OF WHICH ARE EASILY TREATED. REMEMBER, COCCIDIA AND GIARDIA CAN LAY DORMANT IN PUPPIES AND COME OUT DURING THE STRESS OF RELOCATION. THIS IS EASILY TREATABLE AND DOES NOT CONSTITUTE ANY WRONG DOING ON THE PART OF THE BREEDER. THE GUARANTEE DOES NOT INCLUDE ACCIDENTS, NEGLIGENCE, OR ABUSE, NOR DOES IT COVER ANY INFECTIOUS DISEASE CONTRACTED AFTER THE BUYER TAKES DELIVERY OF THE PUPPY. IF A HERNIA PRESENTS ITSELF, THIS CAN BE REPAIRED AT TIME OF SPAY OR NEUTER. ALL VETERINARIAN COSTS ARE THE RESPONSIBILITY OF THE BUYER AFTER THE PUPPY LEAVES SELLER'S PROPERTY. IN ORDER TO VALIDATE THE ONE-YEAR GUARANTEE THE PUPPIES MUST BE SEEN BY YOUR VET WITHIN 72 HOURS OF RECEIVING THE PUPPY. GUARANTEE IS VOIDED IF THE PUPPY HAS NOT CONTINUED ITS FULL VACCINATION SCHEDULE ADMINISTERED BY THE VET. PUPPIES SHOULD NOT BE EXPOSED TO PUBLIC PARKS OR OTHER VULNERABLE AREAS THAT COULD POSSIBLY EXPOSE YOUR PUPPY TO UNWANTED VIRAL/BACTERIAL INFECTIONS UNTIL VACCINATIONS ARE COMPLETE.

THE BUYER AGREES THAT HE/SHE IS NOT ACTING AS OR IS PART OF ANY REPRESENTATIVE IN THE PURCHASE OF THIS PUPPY & THAT THE BUYER WILL NOT SELL THE PUPPY OR ANY OF IT'S OFFSPRING TO ANY REPRESENTATIVE, LABORATORY, ANIMAL BROKER OR PET STORE, OR BREEDER. THESE ARE FAMILY PETS, NOT BREEDING DOGS. PUPPIES ARE SOLD WITH LIMITED REGISTRATION UNLESS DISCUSSED PRIOR TO SALE.

IT IS UNDERSTOOD THAT THE PUPPY SHOULD BE GIVEN PROPER VETERINARIAN CARE. IF THE PUPPY IS FOUND TO HAVE A LIFE THREATENING DEFECT OR DISEASE, AND IS RETURNED TO THE SELLER, THE PUPPY WILL BE EXCHANGED FOR A PUPPY OF EQUAL VALUE WHEN ONE BECOMES AVAILABLE OR SELLER CAN RETURN THE MONEY. A WRITTEN STATEMENT MUST BE PROVIDED BY A LICENSED VET AND SELLER HAS THE RIGHT TO HAVE THE CONDITION VERIFIED BY A VET OF THE SELLER'S CHOICE. PUPPY WILL BE REPLACED ONLY IF DEATH WAS A RESULT OF ILLNESS THAT WAS CONTRACTED PRIOR TO SHIPMENT OF THE PUPPY. IF THE PUPPY DIES FROM A SUSPECTED HEREDITARY OR CONGENITAL DEFECT, THE BUYER'S MUST HAVE A NECROPSY DONE AND REPORT SUBMITTED TO BREEDER. WITH A WRITTEN STATEMENT OF CAUSE OF DEATH BEFORE COMPENSATION OF ANY SORT WILL BE CONSIDERED. THE SELLER REQUIRES BUYER TO PROVIDE A RECORD OF VACCINATIONS AND VET VISITS TO SHOW THAT THE PUPPY HAD RECEIVED APPROPRIATE PREVENTATIVE CARE. REPLACEMENT IS ONE OPTION BUT THE SELLER DOES RESERVE THE RIGHT TO RETURN THE MONEY!!

SELLER CANNOT IN ANY WAY GUARANTEE SIZE AT MATURITY. THE SELLER DOES NOT GUARANTEE ABILITY OF THE PUPPY TO SHOW. SELLER IS BOUND ONLY TO THE ORIGINAL BUYER, NO WARRANTIES, EITHER EXPRESSED OR IMPLIED ARE MADE UNDER THIS CONTRACT EXCEPT AS STATED ABOVE. BUYER AGREES TO THESE TERMS AND GUARANTEES SIMPLY BY THE ACT OF ACCEPTING THE PUPPY, EVEN IF CONTRACT IS NOT SIGNED OR RETURNED. THE DEPOSIT IS A PROMISE BY THE BUYER TO BUY THE PUPPY AND A PROMISE

BY THE SELLER TO HOLD THE PUPPY FOR THE BUYER UNTIL IT IS OLD ENOUGH TO BE SENT.
THE DEPOSIT IS NON-REFUNDABLE IN THE EVENT THE BUYER CHANGES THEIR MIND!!

IF ANY LEGAL ACTION WERE TO BE NECESSARY REGARDING THIS AGREEMENT OR THE
PUPPY IT REFERS TO, BY EITHER BUYER OR SELLER, ALL SUCH ACTIONS MUST BE MADE AND
COMPLETED IN THE TOWN AND STATE IN WHICH THE SELLER RESIDES.
